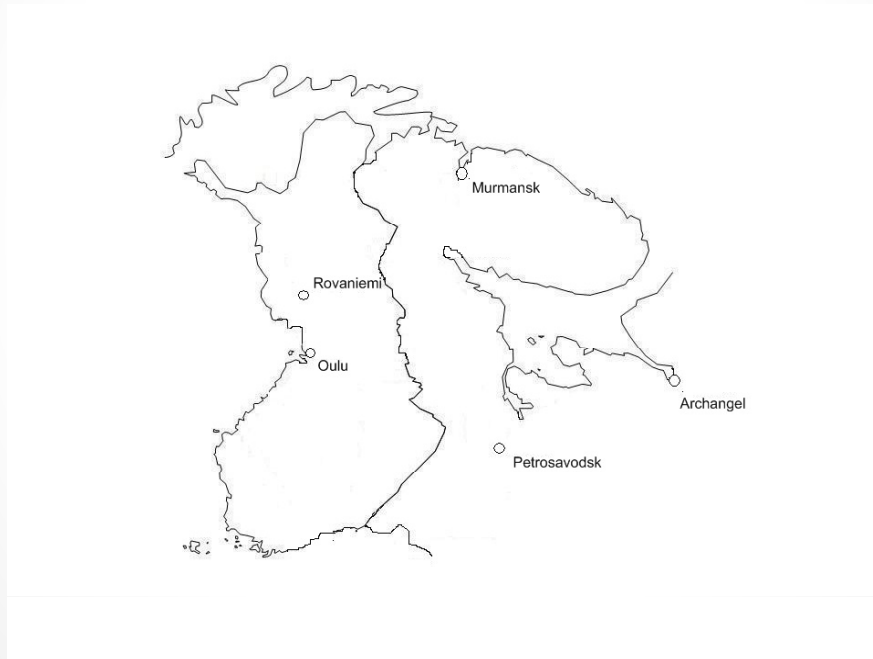

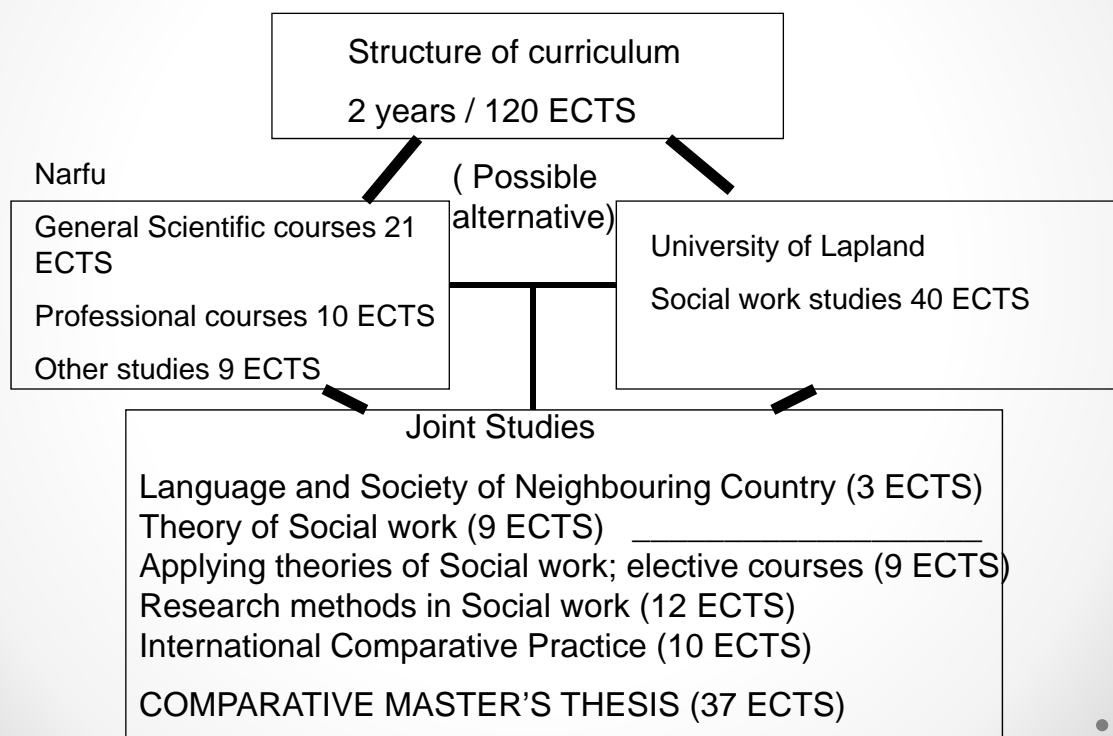




CSW: Partner Institutions and Responsible Units

- There are courses on web environments, intensive courses by visiting lecturers, a Summer and Winter School, student visits, and a period of practice training abroad to acquire experience on multicultural social work in the neighbouring country
- The programme courses and supervision are conducted in English, and Master's thesis research projects will have jointly organised supervision.

Evaluation of first CSW-program 2009-2011

- According to the responsible teachers: insufficient support from the Pomor State University (teacher's workload and salary, expenses of practise fieldment, no working places to teachers and students, problems with high-speed internet, lack of distance courses)
- Unclear responsibility issues
- Unclear status of CSW? – there is no official status? WHY?
- In practice: Students have done more studies than 40 credits at PSU and they have written their thesis in Russian, and some them have got their grades in July, and now they are writing their thesis in English
- Unknown of the BCBU in partner universites; lack of information
- Lack of collaboration at the universities and between universities
- => We need more teachers who can give lectures in English, more students who can study in English, more distance courses, virtual campus, more collaboration in conducting courses together

Proposals

- create conditions for improving MA teacher's work :
- grants, fellowships to partner universities, language courses, research courses (qualitative methods)- BCBU+-project; Summer school and Winter school are open to teachers too
- preliminary student selection (in advance) for the MA program and improving language competence during the year = more English courses to students
- Spreading information in mass-media abroad, using website
- Strengthening individual scientific resource of teachers and student

Programme 2011-13

- Intake in 2011 10 students: 7 has started their studies, 2 of them in November
- Students are from Spain, Russia, Nepal, Iran, Pakistan and Bangladesh. There is no Finnish students
- First programme started in 2009, now first students of CSW are graduating from the ULapland
- Narfu? There was no open call in 2011, there was no marketing, => no possibility to students from Russian partner universities to apply



In the Barents region, social problems and welfare issues have and continue to change, which presents new challenges. Therefore, the need for comparative and international social work has increased in the region. The mobility of labour force presupposes understanding of cultural backgrounds and multicultural social work skills

Comparative Social Work

-a programme for students with a prior academic degree in social work or related field and interested in acquiring

- advanced skills for different carriers
- right for PhD studies

- focuses on acquiring a better understanding of national and global social work, through a comparative approach

Work prospects:

- in different positions in international projects and tasks, as well as social workers.

- the need for experts who have skills to understand international contexts of social issues, as well as a perspective with a comparative approach to different cultural context has increased.

Therefore, work prospects not await graduates only within the region, but also in international tasks round the world.

- Graduates will also have the possibility to continue studies for a PhD and to perform comparative research. In so doing, graduates will be in the front line of promoting scientific research.

Challenges

- Shared understanding of
 - structure (40//40 + 80 + 120 ECTS)
 - collaboration in joint courses; finance, teachers
 - working language
 - thesis; supervision, language; students have told that they have to do more than 40 credits and they have to write their thesis in Russian and they have got the grade for their thesis
 - collaboration between Russian partners

Challenges in Collaboration

- Shared understanding of Social Work
- Shared understanding of doing research (methods, qualitative/quantitative, rules of scientific writing)
- Finance and resources (universities, Kolarctic ENPI, extra funding for development work)
- Commitment (staff changes, English language requirements for teachers, no extra salary)
- Confidentiality ("from speeches to action")
- Full partners/Associate partners; position, responsibilities and benefits of collaboration

- Updating of the Agreement on the Collaboration for planning and implementation of Joint Master's programme in the field of Social work
- BCBU+ -project and CSW: working on-line (virtual courses) is a requirement for development of Joint programme => challenges for teachers

BCBU+ goals

- To harmonize, expand and integrate the BCBU Master's degree programmes to regular activities of participating universities
- To develop models of good practices for implementation and cooperation for cross border master's programmes
- To strengthen and institutionalise a cross border campus for implementing the master's degree and later for the PhD degree education

Virtual Campus

- 1. In order to reduce the impact of geographical distance and travel times upon academic cooperation and the spread of knowledge, the partner institutions will be linked under a common platform to create a '**Virtual campus**'.
- 2. Two of the partners (UL and UO) already utilize eLearning packages to support most curricula, and this will be extended to link all of the institutions involved. This will allow the fast and easy exchange of academic materials, the delivery of parallel and combined courses across borders and simplified planning through a web conferencing facility.

Virtual campus

- – Establishment of common eLearning and web conferencing platform
- – To increase availability of academic and research material

Translation of selected material into English or Russian and dissemination of them via the Virtual Campus

- – To publish the **Cross Border Cooperation handbook**
