



## II Programme 2011-13

- In UL: intake in 2011 10 students: 7 has started their studies, 2 of them in November
- Students are from Spain, Russia, Nepal, Iran, Pakistan and Bangladesh, there is no Finnish students
- Group is very active and motivated to study
- First programme started in 2009, now first students from UL from CSW

## II Programme 2011-13

- In Narfu: Social work education is in the transitional state: we ask ourselves "What is social work", "What is the mission of social work", "What and how to teach social work"
- Planning the new content of the Master Program (40 ECTS). Planning to open different MPs in Russian
- Develop new courses
- Enlarge hours for the English language at Bachelor level
- Seek for political support at the local administrative level

## Master's degree in CSW 2011-2013

- Requires revision and analysis of the content of the courses
- The main criteria for "approval" of the courses should be based on the values common for us, ex.
- Promote a northern voice that reflects a shared regional identity
- 2. Promote understanding among different learning systems
- 3. Promote cultural diversity and gender equality
- 4. Empowerment of the residents by building human capital
- 5. Creation of shared knowledge and provision for quality discussion

- Holistic approach in building up the curricular is hard to achieve at the moment, because of the different scientific paradigms and methodology in Social Work education and practice.
- Highly political character of social work and the stated above difficulties make it reasonable to choose critical reflection and scientific sensitivity as the major students' skills we will aim to develop

# Evaluation of first CSW-programm 2009-2011

- According the responsible teachers: Insufficient support from Pomor State University (teacher's workload and salary, expenses of practise fieldment, problems with high-speed internet, lack of distance courses)
- Unclear responsibility issues
- Unclear status of CSW? –
- In practice: Students have done more studies than 40 credits at PSU and they have written their thesis in Russian and in english
- Unknown of the BCBU in partner universites; lack of information
- Lack of collaboration at the universities and between universities
- => We need more more teachers who can give lectures in english, more students who can study in english, more distance courses, virtual campus, more colloboration conducting courses together,

# Challenges in Collaboration (1)

- Shared understanding of Social Work
- Shared understanding of doing research (methods, qualitative/quantitative, rules of scientific writing)
- Finance and resources (universities, Kolarctic ENPI, extra funding for development work)
- Commitment (staff changes, English language requirements for teachers, no extra salary)
- Confidentiality ("from speeches to action")
- Full partners/Associate partners; position, responsibilites and benefits of collaboration

# Challenges in Collaboration (2)

- Updating of the Agreement on the Collaboration for planning and implementation of Joint Master's programme in the field of Social work
- Associate partners=> Full partners (MSHU, PetrSU)
- BCBU+ -project and CSW: working on line (virtual courses) is a recuirement for development of Joint studies => challenges for teachers

- Start to plan together the new study guide (2013-2015
- Using Optima as a tool (CSW and BCBU+ project)
- Virtual courses: AdobeConnectpro link to give lectures to CSW partner universities

### Proposals

- create conditions for improving MA teacher's work
- grants, fellowships to partner universities, language courses, research courses (qualitative methods)-
- BCBU+ -project; Summer school and Winter school are open to teachers too
- Spreading information in mass-media abroad, using website and social media
- Strengthening individual scientific resource of teachers and student
- Have to start to plan postgraduate studies and develop the collaboration in research of social work field
